#### **3** Important notes on eligibility (nationality, academic background, language proficiency)

- International students who have completed the full primary and secondary education curriculum in a country that adopts an education system of less than 12 years are recognized as having equivalent academic qualifications to high school graduates in Korea. (Reference: Article 98, Paragraph 1, Clause 9 of the Enforcement Decree of the Elementary and Secondary Education Act)
- 2) Students who have completed the final three years of an 11-year or 12-year primary and secondary education system in the respective country are recognized as having completed high school education. (However, students must have completed at least 11 years of primary and secondary education across two or more countries to be recognized.)
- 3) Applicants must submit official supporting documents if they have any special circumstances related to family status or nationality, such as divorce, remarriage, unmarried status, death, missing persons, or acquisition/loss of Korean nationality.

Example: Divorce certificate, single-parent certificate, death certificate, etc.

- 4) Academic qualifications obtained through GED, domestic or international equivalency exams, homeschooling, online learning, or adult education programs are not recognized as meeting the academic requirements for admission.
- 5) International students whose both parents are foreign nationals are eligible for transfer admission if they have completed at least one year at a domestic or international university. The recognition of previously earned credits and courses will be determined in accordance with Halla university's academic regulations.
- 6) International students admitted to Halla University must obtain at least Level 4 in the Test of Proficiency in Korean (TOPIK) or complete Level 4 of the Social Integration Program (or an equivalent qualification) to be eligible for graduation. (This requirement does not apply to students enrolled in English-track programs.)
- 7) Students enrolled in English-track programs must complete at least 50% of the required graduation credits in English.

#### **3** Important notes on application schedule

- ※ Dual Degree Program: Only students from universities that have an agreement with Halla University are eligible to apply for the dual degree program.
- Wisa Requirement: Applicants must obtain a D-2-2 visa (for undergraduate freshmen, transfer students, and dual degree program students) before enrollment.
- \* Visa and Entry Issues: Even if an applicant is accepted and has completed registration, admission will be canceled if their visa application is denied or if they are unable to enter Korea.
- \* False Information: If any false information is found in the application or submitted documents, the applicant will be solely responsible, and their admission may be revoked.
- \* Submission Responsibility: Applicants are responsible for ensuring that all required documents are submitted within the deadline. Late or missing documents will be the applicant's responsibility.
- \* Changes to the Schedule: The above schedule is subject to change. Any updates will be announced on the Halla University website (www.halla.ac.kr). (No individual notifications will be sent to applicants.)

- All documents must be accompanied by an English or Korean translation and notarized.
- Additional documents may be requested from applicants if necessary for eligibility screening.

#### **2** Important notes on document submission

- 1) All documents submitted by applicants will not be returned.
- 2) For documents not written in Korean or English, a notarized Korean (or English) translation must be submitted.
- 3) Prospective graduates must submit relevant academic verification documents within the deadline specified by the university after graduation. Admission may be canceled if proof documents are not submitted before admission or if visa acquisition is delayed due to late submission.
- 4) Applicants planning to submit language proficiency documents may be conditionally accepted on the condition of submitting the official TOPIK score report or language institute completion certificate and transcript. Final acceptance will be granted upon submission of the final language proficiency documents. Acceptance may be canceled if documents are not submitted by the deadline or if eligibility requirements are not met.
- 5) If it is found that admission was obtained through fraudulent means such as forgery or alteration of submitted documents, lack of eligibility, proxy testing, etc., before or after admission, acceptance and admission will be canceled. In such cases, paid tuition fees will not be refunded.
- 6) Matters not included in this admission guide will be decided by the university's Admission Management Committee, and all matters after admission will follow the university's regulations.

#### Apostille Certificate Submission Guide

#### 1) Apostille Convention:

A multilateral convention that simplifies the authentication process for public documents between member countries by abolishing complex procedures such as consular authentication and instead having the issuing country verify the documents

#### 2) Documents subject to Apostille verification:

Documents issued by foreign government agencies and documents notarized by notaries public

O Documents issued by foreign government agencies: Family relationship certificates, transcripts issued by public schools, etc.

 O Notarized documents: Certificates issued by private schools, medical certificates, documents issued by companies and banks, etc.

\* Applies only to countries that have joined the Apostille Convention

(For non-member countries, submit notarized documents or consular authentication)

#### 3) Issuance method:

Apply for and obtain an Apostille certificate from the designated government agency in the country where the school is located for various certificates issued by foreign schools (In the case of the Republic of Korea, the Ministry of Foreign Affairs)



#### **4** Important notes on selection method

- 1) Failure to submit required documents for document evaluation will result in disqualification.
- 2) Applicants deemed to lack academic ability based on qualification screening and interview results will not be granted admission.
- 3) Matters related to evaluation and deliberation are decided by Halla University's Admission Management Committee, and other matters follow Halla University's admission procedures and regulations.
- 4) Qualification review scores and evaluation contents are not disclosed.
- 5) In case of tied scores, all applicants will be accepted, and interviews will be conducted in Korean(Korean Track)/ English(English Track).

# **Other Important Notes for Applicants**

- Applicants must accurately enter personal information, contact details, admission type, and department at the time of application. Any disadvantages caused by incorrect information will be the sole responsibility of the applicant.
- Multiple applications within Halla University are not allowed.
- Once the application is submitted, modifications or cancellations are not permitted, and submitted documents will not be returned.
- All documents must be original copies. If a copy is submitted due to unavoidable circumstances, the original must be submitted within the designated registration period after acceptance.
- Applicants must bring their ID (passport or alien registration card) on the day of the interview.
- Admission results will not be individually notified. Applicants must check their results on the university website on the announcement date.
- Accepted students under the special admission program for international students cannot enroll in more than one university. They must choose only one university for registration.
- Tuition fees must be paid within the designated period to the university's specified account. Failure to pay within the deadline will result in admission cancellation.
- Even if an applicant is accepted and has completed registration, admission will be revoked if their visa application is denied or if they are unable to enter Korea.
- Admission may be canceled if the applicant cannot legally stay in Korea due to restrictions on visa extension or status change under the regulations of the Immigration Office.
- Applicants who do not have a TOPIK Level 3 or higher at the time of admission must complete at least 300 hours of Korean language courses during their first year at the university.
- All students must obtain a TOPIK Level 4 or higher or complete Level 4 of the Korea Immigration & Integration Program (or an equivalent qualification) to graduate. (This requirement does not apply to students in English-track programs.)
- All information in this admission guide will not be individually notified. Applicants must thoroughly review the details, as any disadvantages resulting from a lack of awareness will be the applicant's responsibility.
